THE VACC OFFERS AGING ADULTS OPPORTUNITIES TO IMPROVE THEIR PHYSICAL HEALTH AND WELLNESS, SOCIALIZE WITH PEERS, AND ACCESS ADDITIONAL SERVICES. MEMBERS PARTICIPATE IN A WIDE VARIETY OF GROUP EXERCISE, WATER EXERCISE, AND YOGA CLASSES; FITNESS CENTER WORKOUTS, SOCIAL ACTIVITIES, ARTS PROGRAMMING, EDUCATIONAL LECTURES, AND EVIDENCE-BASED HEALTH CLASSES SUCH AS DIABETES PREVENTION PROGRAM AND LIVING WITH CHRONIC CONDITIONS.
