THE VACC OFFERS AGING ADULTS OPPORTUNITIES TO IMPROVE THEIR PHYSICAL HEALTH AND WELLNESS, LEARN NEW SKILLS, SOCIALIZE WITH PEERS, AND ACCESS ADDITIONAL SERVICES. MEMBERS PARTICIPATE IN A WIDE VARIETY OF GROUP EXERCISE, WATER EXERCISE, AND YOGA CLASSES; FITNESS CENTER WORKOUTS, SOCIAL ACTIVITIES, ARTS PROGRAMMING, EDUCATIONAL LECTURES, AND EVIDENCE-BASED HEALTH CLASSES SUCH AS DIABETES PREVENTION PROGRAM AND WALK WITH EASE. THE VACC INCLUDES A STATE-OF-ART FITNESS CENTER, INDOOR WALKING TRACK, GROUP EXERCISE AND PROGRAM ROOMS, AND A WARM WATER EXERCISE POOL. IN FY23, THE VACC HAD APPROXIMATELY 1,835 MEMBERS, LOGGING OVER 82,877 IN-PERSON AND 5,505 VIRTUAL PHYSICAL FITNESS ACTIVITIES.
